St Louis Audubon organizes and supports community workdays that utilize volunteers to restore bird and wildlife habitat at select natural areas, designated as Important Bird Areas, in the St Louis region, including Creve Coeur Lake Memorial Park, Cuivre River State Park and the Castlewood State Park

St Louis Audubon's Bring Conservation Home program provides on-site habitat restoration assistance and certification for private lands across the St Louis region. The program addresses native and invasive plants, water conservation and wildlife stewardship for the benefit of birds, wildlife and people. The program was initially focused on residential landscapes, but will eventually utilize a broad community partnership of organizations, agencies and corporations to reach all types of private spaces

St Louis Audubon provides free educational services to the public, including in-class programs to K-12 students in public and private schools, adult oriented programs to garden clubs, churches and other community based groups, and family oriented programming at community events around St Louis such as Eagle Days, Wetlands for Kids and Wings of Spring. In addition, scholarships are provided to graduate students in biology and for science teacher training. Audubon also works to protect and restore birds and their habitat by advocating for birds to government officials and agencies, identifying and protecting important Bird Areas (IBA), funding species-specific projects within those IBAs, supporting citizen science efforts and providing free materials to the public outlining bird-friendly practices for public and private lands
